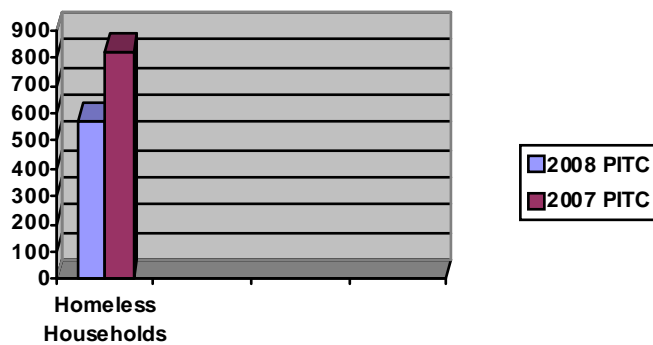


On January 29, 2008, 841 adult respondents in Hudson County answered the statewide Point in Time Survey, whose purpose is to gather information on residents who are homeless or precariously housed. Of the 841 respondents to the survey, **572 households indicated that they were homeless** according to the U.S. Department of Housing and Urban Development's definitions of homelessness.

### SECTION I: WHO ARE THE HOMELESS IN HUDSON COUNTY

According to the 2008 Point in Time Count (PITC), 572 adults and 352 children were homeless in Hudson County on the night of the count. The number of homeless households in 2008 was 30% less than the number identified in the 2007 PITC.



The 2008 PITC includes only a subset of those who are homeless or at risk of homelessness in New Jersey. By its nature, a point in time count captures information only on those who are both homeless on that night and who can be identified by those administering the surveys. The actual number of people who are homeless over the course of the year may be between two to four times larger than the number counted at one point in time. Using the statistical formula developed in the publication "Estimating the Need," it is projected that over the course of a year, 1,036 adults and children are homeless in Hudson County.<sup>1</sup>

Respondents were considered homeless if they met the definition of homelessness adopted by the U.S. Department of Housing and Urban Development. Included in this definition are those who are currently living on the streets or in places not meant for human habitation, those living in emergency shelters (including domestic violence shelters and youth homeless shelters), those living in transitional housing for the homeless, and those living in hotels or motels whose stays are paid for by an outside agency. While the focus of the PITC was on those who were homeless, the survey also gathered information on respondents who indicated that they were living in permanent supportive housing, as well as those who were precariously housed, living in substandard

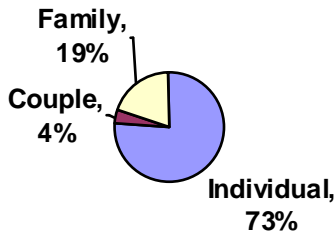

housing, living in overcrowded housing, or staying with friends or family due to the lack of their own housing.

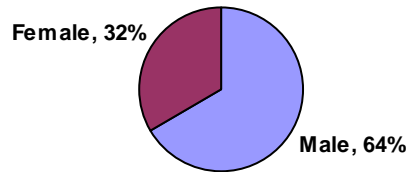
Demographic Information

Of the 572 homeless adults in Hudson County on January 29, 2008, the overwhelming majority were single individuals without children in their care (73%, n=419). 19% of respondents (n=109) were families with children, while 4% were couples (married or living together) (n=24). 64% of adults were male (n=366) and 32% were female (n=183). 44% (n=249) of survey respondents were Black, 35% (n=201) were White, and 6% (n=32) were American Indian/Alaskan Native, Asian, or Native Hawaiian/Other Pacific Islander. 32% (n=181) of respondents identified themselves as Hispanic or Latino.

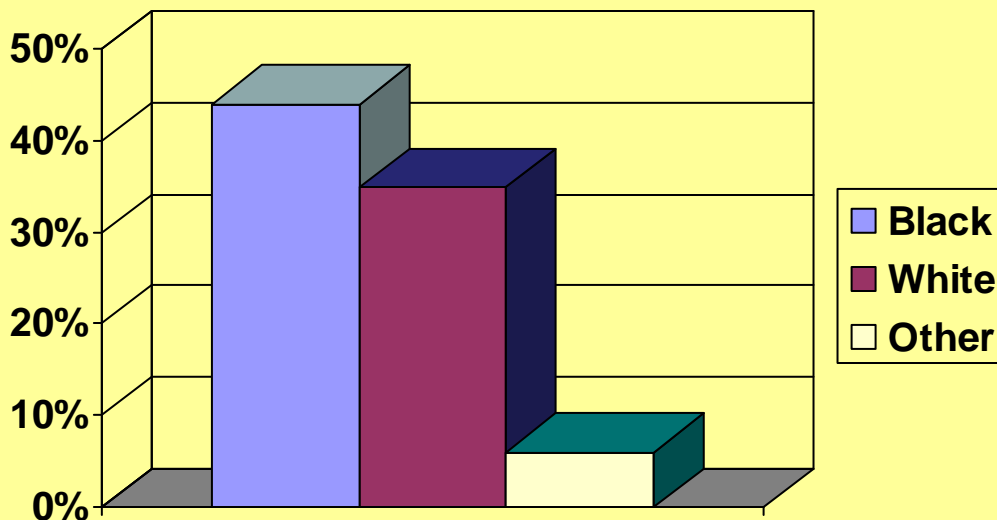
**Characteristics of PITC Respondents -- Household Status**



**Characteristics of PITC Respondents -- Gender**

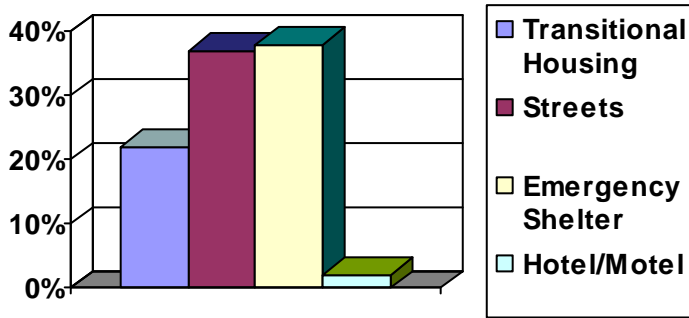


**Characteristics of PITC Respondents -- Race**

Sleeping Accommodations on Any Given Night



**CURRENT AND PAST LIVING SITUATION**

Emergency shelters provided housing for 38% of homeless adults and families on the night of the PITC (n=219). 22% (n=123) of respondents stayed in transitional housing for the homeless, and 2% (n=12) were staying at motels paid for by an agency due to their lack of housing. 37% (n=212) of the homeless spent the night on the streets or in a place not meant for human habitation (such as their car, a local transportation center, or an abandoned building), or had nowhere to stay and had not determined

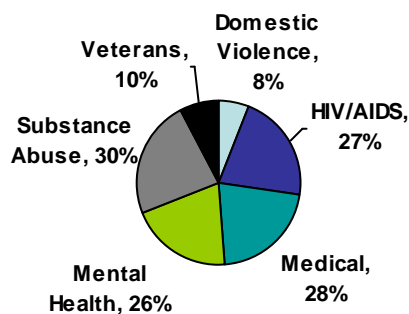
where they would spend the night.

Jersey City was named by the largest number of Hudson County respondents (55%, n=315) as the place they last lived before becoming homeless. The overwhelming majority of homeless people in Hudson County (83%, n=475) had lived in New Jersey before becoming homeless, with 16% (n=97) reporting that their last residence was outside the state. 89% (n=510) were residents of the United States before becoming homeless.

**HOMELESS SUBPOPULATIONS AND CONTRIBUTING FACTORS TO HOMELESSNESS**

Homeless Subpopulations As Reported by Respondents



Respondents to the PITC identified a number of issues that may have contributed to their homelessness. 151, or 26%, of homeless people indicated that they would benefit from mental health services, 174, or 30%, indicated usage or need for substance abuse services, and 160, or 28%, indicated usage or a need for medical care for a

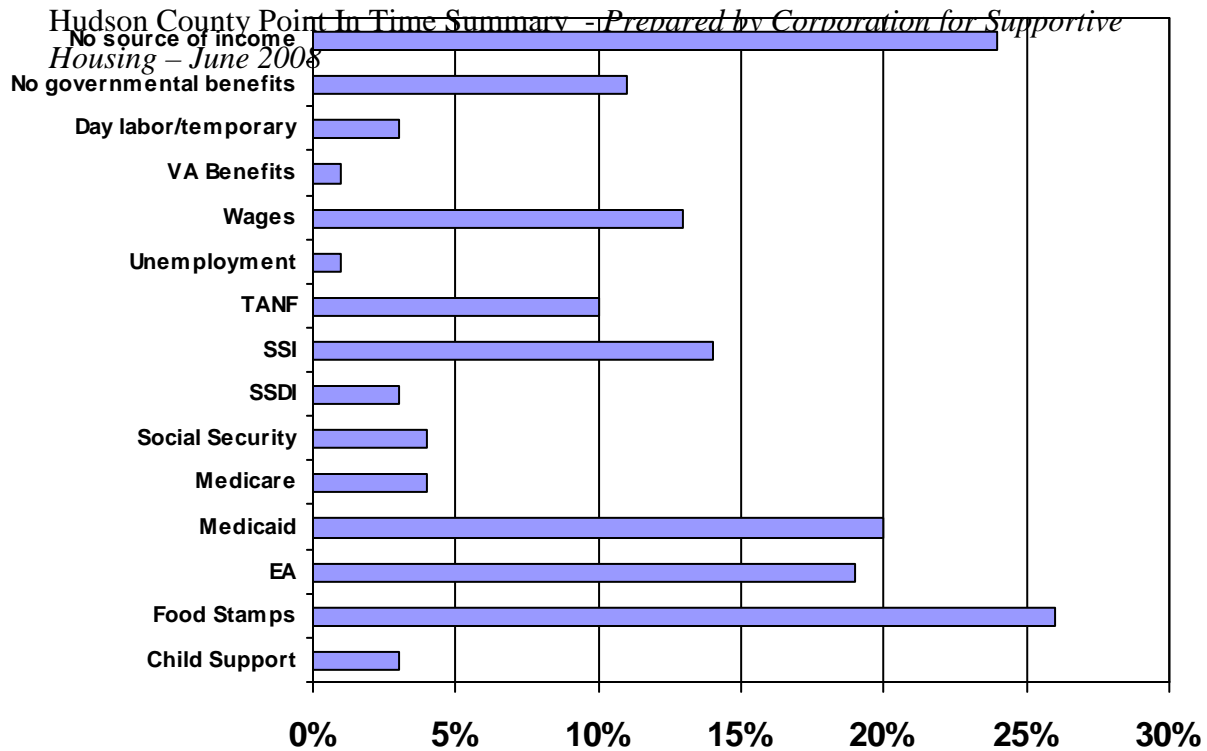

disability. 8% (n=45) of homeless people had a history as survivors of domestic violence, and 27% (n=152) were living with HIV/AIDS. 10% (n=59) of people who were homeless on the night of January 29 were veterans.

The 2008 PITC survey also gathered information on respondents' service usage, service needs, and services that they had been denied. As demonstrated in the chart below, the greatest service needs indicated by respondents included a need for housing (50%), a need for employment assistance (25%), and educational training (22%).

## Income Sources (Percentage)

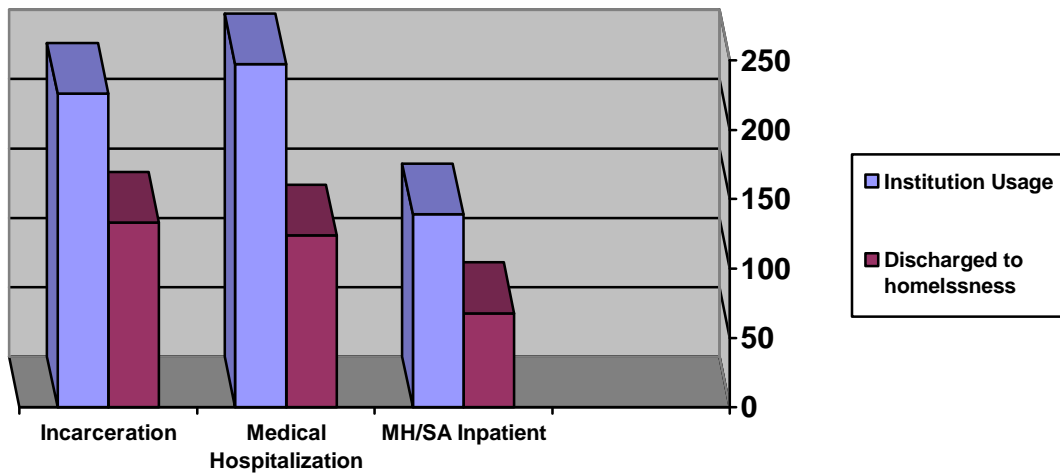
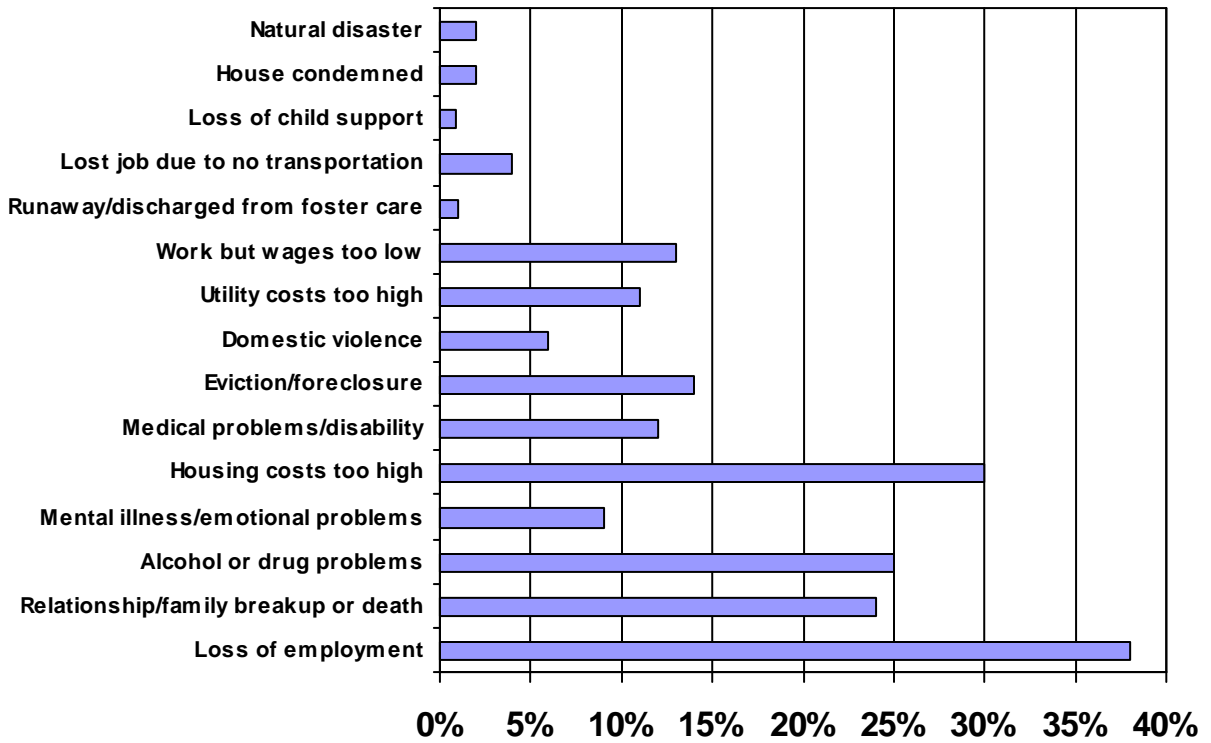


The majority of people who were homeless (67%, n=386) reported that they received some form of income. Food stamps was the single highest source of income for respondents (26%, n=151). Medicaid was received by 20% (n=116) of respondents and 19% (n=111) of respondents received Emergency Assistance/Public Assistance/Welfare. 92, or 16% of people who were homeless on the night of the 2008 PITC count were employed.

When asked what factors contributed to their homelessness, the most common factors included loss of employment (38%), unaffordable housing costs (30%), alcohol or drug abuse problems (25%), and relationship/family breakup/death (24%).

40% (n=226) of respondents indicated that they had been incarcerated, and of that group, 59% (n=133) had been discharged into homelessness. 43% (n=247) indicated that they had been hospitalized or required emergency room or acute medical care, and of that group, 50% (n=124) had been discharged into homelessness. 24% (n=139) had received inpatient care in a mental health or substance use facility, and of that group, 49% (n=68) indicated that they had been discharged into homelessness.

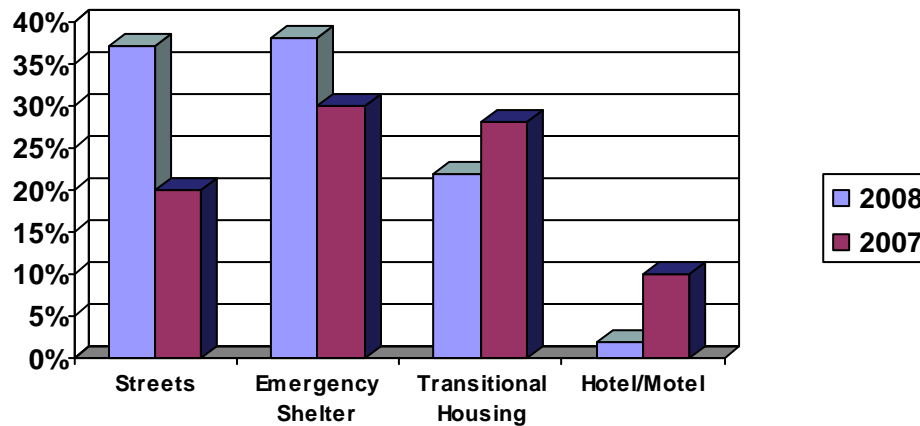
8% (n=44) of homeless respondents were in foster care as children. 66% (n=375) had photo ID. 9% (n=53) indicated that they had a car or other adequate means of transportation.

**COMPARISON OF 2008 AND 2007 PITC DATA**

The 2008 PITC survey gathered significantly more information about respondents than the 2007 survey, including gathering information from those whose answers indicated that they were not homeless by HUD's definition (including the precariously housed, those "doubled up" or living temporarily with family or friends, etc.).

In 2008, the number of homeless households was 30% lower than the number reported in 2007 (n=572 vs. n=822). While the number of homeless households has decreased, the characteristics of those people who are homeless have remained largely the same. In Hudson County, emergency shelter continued to be the largest housing resource for homeless households, with 38% of homeless people residing in emergency shelter in 2008 and 30% in 2007. In both years, respondents indicated high levels of need and/or usage for mental health and substance abuse services (26% in 2008 vs. 20% in 2007 for mental health services and 30% vs. 27% for substance abuse services).

**Sleeping Accommodations 2008 vs. 2007**



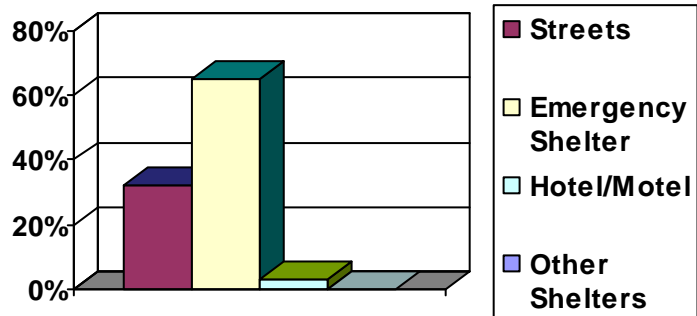
**SECTION 2: CHRONICALLY HOMELESS**

A subset of the homeless population is those who are chronically homeless. According to HUD, a chronically homeless citizen is an unaccompanied adult with a disabling condition who has either been continuously homeless for a year or more or has had at least four homeless episodes in the past three years.

According to the 2008 PITC, 93 individuals were chronically homeless on the night of the count. This represents 16% of the total adult homeless population in Hudson County on that night.

65% (n=60) of the chronically homeless were living in emergency shelters, 3% (n=3) were living in motels paid for by an outside agency, 16% (n=15) had nowhere to stay and did not know where they would spend the night, 16% (n=15) were spending the night on the streets or in places not meant for human habitation.

**Sleeping Accommodations on Any Given Night**



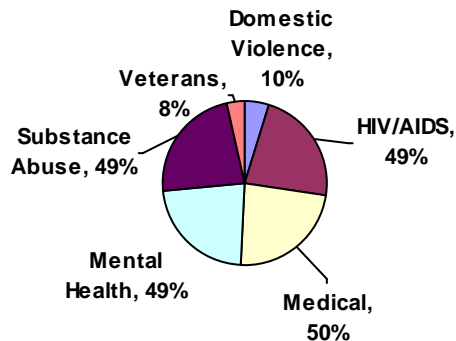
*Demographics*

41% (n=38) of the chronically homeless population was white and 38% (n=35) was African American. 7% were American Indian/Alaskan Native, Asian or Native Hawaiian/Pacific Islander. 33% (n=31) were Hispanic/Latino. 60%, or 51, individuals were male and 37%, or 34, were female. While chronically homeless people are individuals unaccompanied by children on the night in question, 49% (n=46) indicated that they did have children who were either adults or not in their care. 5% (n=5) spent time in foster care as children.

75% of people who were chronically homeless had been homeless for one year or more (n=70). 84% (n=78) had been homeless at least four times in the last three years.

Among the chronically homeless population, 49% (n=45) reported a need for or usage of mental health services, 49% (n=46) reported a need for or usage of substance use services, 50% (n=47) reported a need for or usage of medical services for a disability, 10% (n=9) reported a need for or usage of domestic violence services, 49% (n=46) reported a need for or usage of HIV/AIDS services, and 8% (n=7) were veterans.

**Homeless Subpopulations As Reported by Respondents**

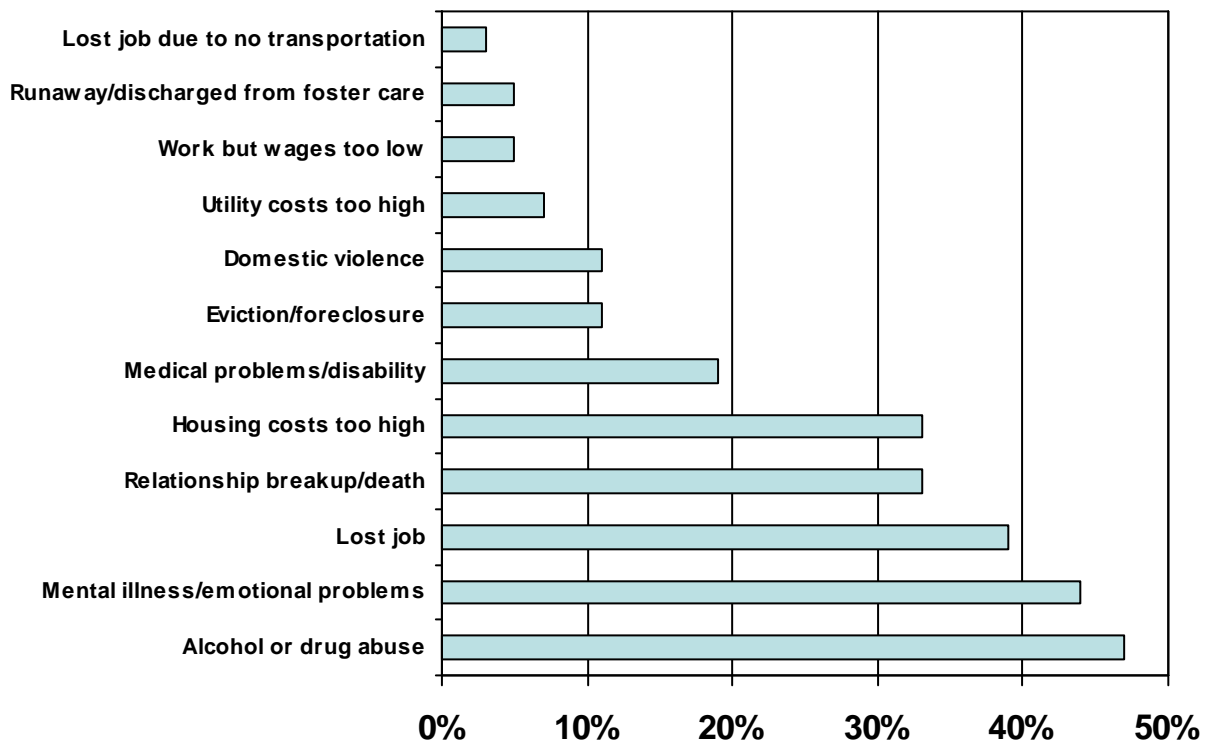


*Contributing Factors to Homelessness*

72% of all chronically homeless individuals who responded to the income indicated some form of income. The single most common form of income reported was Emergency Assistance/General Assistance/Welfare (29%, n=27). 28% (n=26) reported receiving food stamps, 24% (n=22) reported receiving SSI, and 11% (n=10) were employed.

When asked to name factors that contributed to their homelessness, 37% (n=34) reported alcohol or drug abuse problems, 23% (n=21) reported mental health issues or emotional problems, 40% (n=37) reported the loss of a job, and 31% (n=29) cited the unaffordable cost of housing.

54% (n=50) of chronically homeless citizens reported a history of incarceration. Of those individuals, 72% (n=36) said they had been discharged from jail or prison into homelessness. 63% (n=59) reported a history of medical hospitalizations, and of those individuals, 75% (n=44) reported being discharged into homelessness. 34% (n=32) reported a history of mental health or substance use inpatient treatment, and of those individuals, 78% (n=25) reported discharge into homelessness.
